

Camper UK “Go Further” A-Class Offer

Terms & Conditions

- 1. The Camper UK Go Further A-Class Offer is available from 15 September 2026 on selected qualifying new and used A-Class motorhomes purchased from Camper UK Ltd.**
- 2. To qualify, the customer must place a new qualifying order on or after 15 September 2026. Orders placed before 15 September 2026 are not eligible, even if the vehicle is paid for, collected or handed over after the promotion start date.**
- 3. For the purposes of this promotion, an order is considered placed once the qualifying vehicle order has been accepted by Camper UK and any required deposit has been received.**
- 4. The promotion applies only to selected new and used A-Class motorhomes specifically identified by Camper UK as qualifying for the offer. Not every A-Class motorhome will necessarily be included.**
- 5. Eligible customers will receive a promotional contribution of up to £1,500 towards the purchase of a qualifying motorhome.**
- 6. The promotional contribution will be applied as a reduction to the agreed purchase price of the qualifying motorhome at the point of sale.**
- 7. The exact promotional contribution available may vary by vehicle, up to a maximum of £1,500. The amount applicable to the chosen vehicle will be confirmed by Camper UK before completion of the purchase agreement.**
- 8. The promotional contribution will be recorded on the customer's sales order or other relevant purchase documentation.**
- 9. The Go Further – Fuel Your Adventure campaign uses the contribution to represent money that could be put towards the customer's future touring and fuel costs. The promotion does not provide a separate fuel card, fuel voucher or fuel reimbursement.**
- 10. No fuel receipts, reimbursement claims or subsequent applications are required.**
- 11. The maximum promotional benefit available is £1,500 per qualifying motorhome.**
- 12. The offer is non-transferable and applies only to the customer named on the qualifying vehicle purchase agreement.**
- 13. The promotional contribution has no cash alternative and cannot be exchanged for cash separately from the qualifying motorhome purchase.**

18. Qualifying vehicles are subject to availability. Camper UK may add or remove vehicles from the promotion before an order for that vehicle has been accepted.
19. Camper UK reserves the right to amend, suspend or withdraw the promotion in relation to future orders. Any amendment or withdrawal will not affect a qualifying order already accepted under the promotion, except where required by law or due to circumstances outside Camper UK's reasonable control.
20. Camper UK reserves the right to refuse the promotional contribution where it reasonably believes the terms of the promotion have not been met or false, misleading or fraudulent information has been provided.
